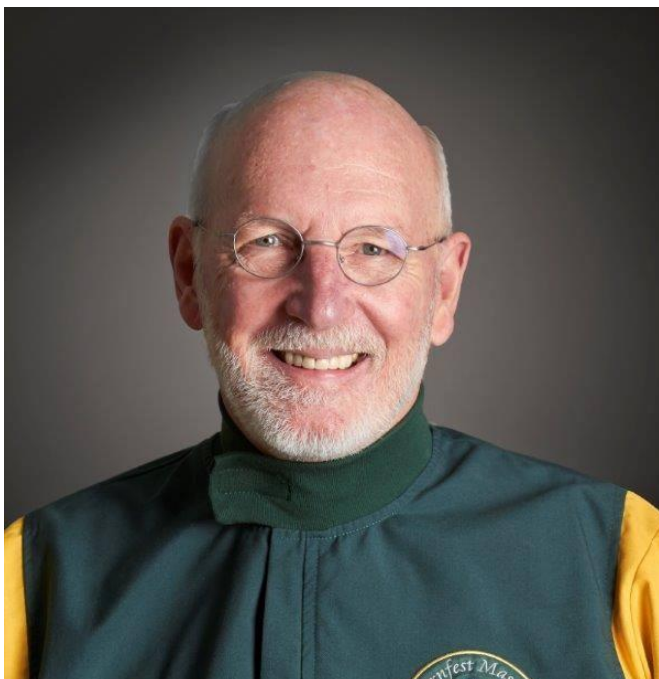

Tom writes, "During this demonstration, I will turn a platter using my two-step turning process. I will discuss the anatomy of a well-turned platter, including choice of woods, proportions, pleasing curves and lines, transitions and details, sanding and finishing. I will explain each process step in turning a platter, with special emphasis on chucking techniques and the use of gouges and scrapers in the two-step turning process. I will also demonstrate how I grind my gouges and scrapers and explain my preferences in tool steels and grinders.

UNMH Children's Cancer Facility has been treating nearly one hundred seriously ill cancer youngsters each year. For each medical treatment a child receives, he or she gets a bead which they can then keep in their bowl, hence Beads of Courage Bowls. The children do receive a bag to put their beads in but a Beads of Courage Bowl is far more special and reflective of the hard work to beat cancer!

Did any other NMWT members attend SWAT? What were your favorite demos? What pieces in the gallery inspired you recently?

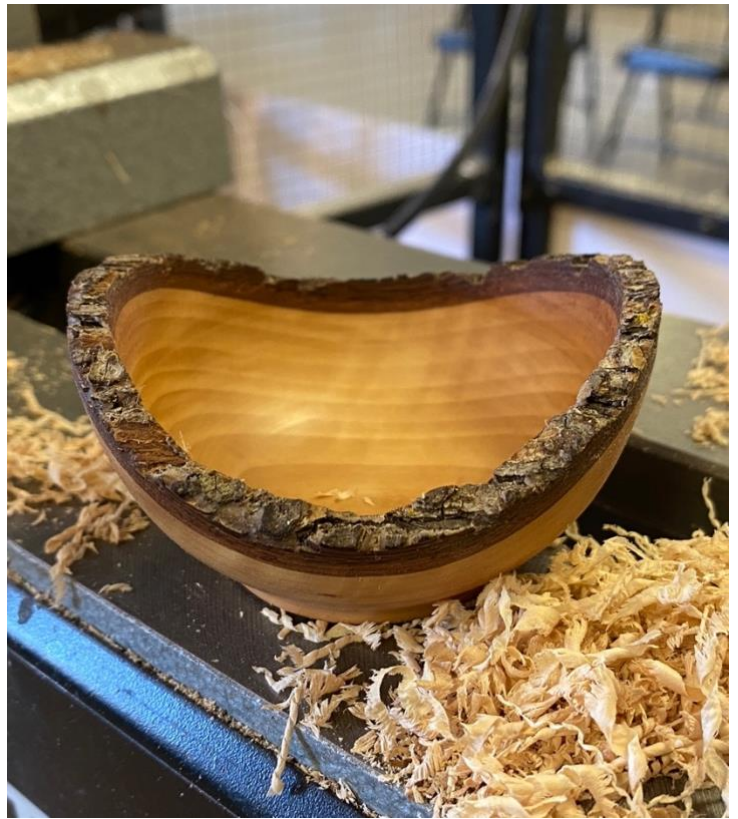


State Fair Fun

August's Demo: State Fair Projects



In August we enjoyed several demonstrators sharing projects that are hot State Fair projects. We kicked it Hy Tran turning a small, lidded box. Following Hy, Patricia Apt, knocked it out of the park with miniature goblets.

A huge impact can come from these little projects.

August's Demo: State Fair Projects Cont'd

Following the break and instant gallery, Bill Mantelli demonstrated a crowd favorite – the spinning top. By far, the tops were the most common giveaway to onlookers. Also, a big thanks to Albuquerque Exotic Woods for donating the maple turning stock for tops, goblets, boxes, etc. Following Bill, Kay Grant showed us how to upscale a Bic ballpoint pen on some dowel stock.



September's Demo: Mini Hollow Forms w/ Patricia Apt



September's demo was all about miniature turning by Patricia Apt. We got the sneak peak of her miniature goblets in August. That quick goblet demo fueled the fire for how Patricia turns her spectacular miniature hollow forms. Below is a small spread of her magnificent work.



After showing several of Patricia's pieces, she began turning a red gum hollow form in spindle orientation – hollowing end grain. Patricia emphasized making a robust spigot for the jaws to grip. She then began shaping the form with an eye for a pleasing curve yet leaving plenty of "meat" at the bottom to allow for hollowing while minimizing vibration. Once the vessel's shape is pleasing and the lip is defined, Patricia turned to hollowing. Patricia uses a number of hollowing tools – many which she's modified to fit her needs. Below, you can see some of her tools. Some from upcycled Allen keys, one made by fellow NMWT member Bill Zerby and custom calipers brazed by Patricia from brass rod and tubing.



September's Demo: Mini Hollow Forms Cont'd



Above, you'll note that the cutting edge of the modified Allen key is in line with the shaft of the tool. This gives the turner the ability to "picture" the cutting edge in the form. Slow, steady sweeping of the tool hollows the form. Patricia then hollows the form to a desired thickness. Below, she uses her custom thickness calipers to determine wall thickness at the top curve of the form. Once the hollowing is complete to liking, finish shaping the form with clean cuts accounting for the internal thickness.



September's Demo: Mini Hollow Forms Cont'd



Once Patricia refined the final shape, she begins the step of parting off the vessel. She carefully parts down to a comfortable diameter then completes sanding and finishing. Once finished with friction polish, Patricia uses a small parting tool, ground at a bit of an angle off 90 degrees, to separate the piece very close to the vessel to minimize the need for sanding the bottom.



September's Demo: Mini Hollow Forms Cont'd

The second half of the demo, Patricia showed us how to turn a miniature vessel in different grain orientation. Often times, more figured woods benefit from being turned in a side grain orientation – also referred to as face grain or bowl orientation. Below, this figured maple vessel show off the curl really well. This would be lost if turned in end grain orientation. The key here is to make a larger, more precise tenon to fit in the chuck jaws. The support is essential when hollowing. The vessel is shaped to suit the turner and special attention is paid to the rim and lip. There's no coming back it.



Patricia hollows the piece as shown earlier carefully measure depth. Once the hollowing is complete, the final shape is defined. As Patricia refines the shape, she frequently measures the wall thickness with other custom thickness calipers she's made. In the above photos you can see the pleasing shape come about. After you're happy with your shape, turn your attention to sanding and finishing. On the next page, you'll see this miniature vessel come to life.

September's Demo: Mini Hollow Forms Cont'd



Pictured above and below are little pearls Patricia shared to finishing these stunning little vessels that scream success. Patricia used sandpaper rolled into a cone to sand the opening and a small compact mirror to inspect the progress and finish as well as increase light reflection into the form. With some finish it goes pop!

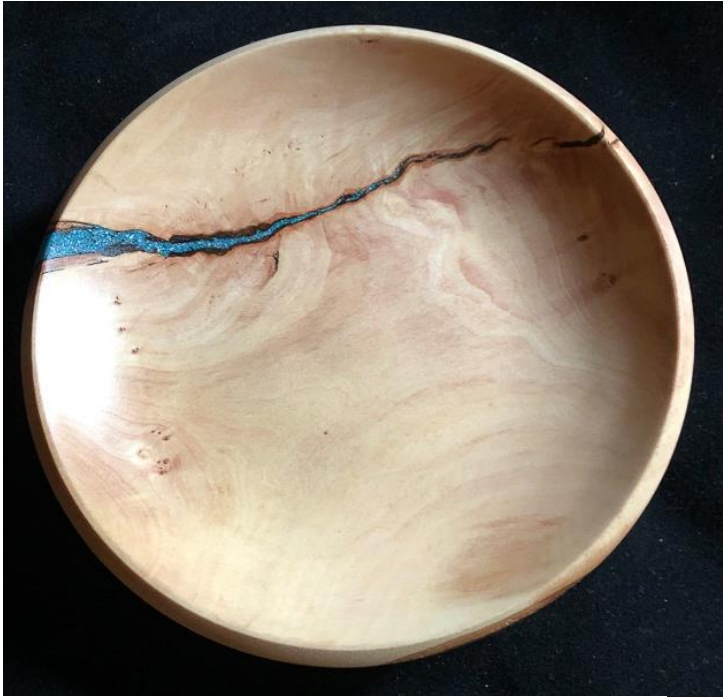

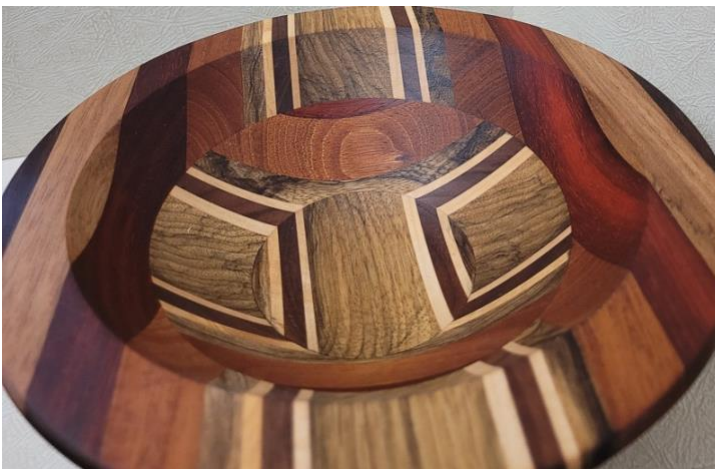

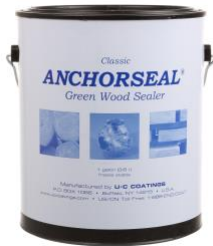


Above: Jeff Palmer shares the start of an elm bowl ready for rounding and shaping.

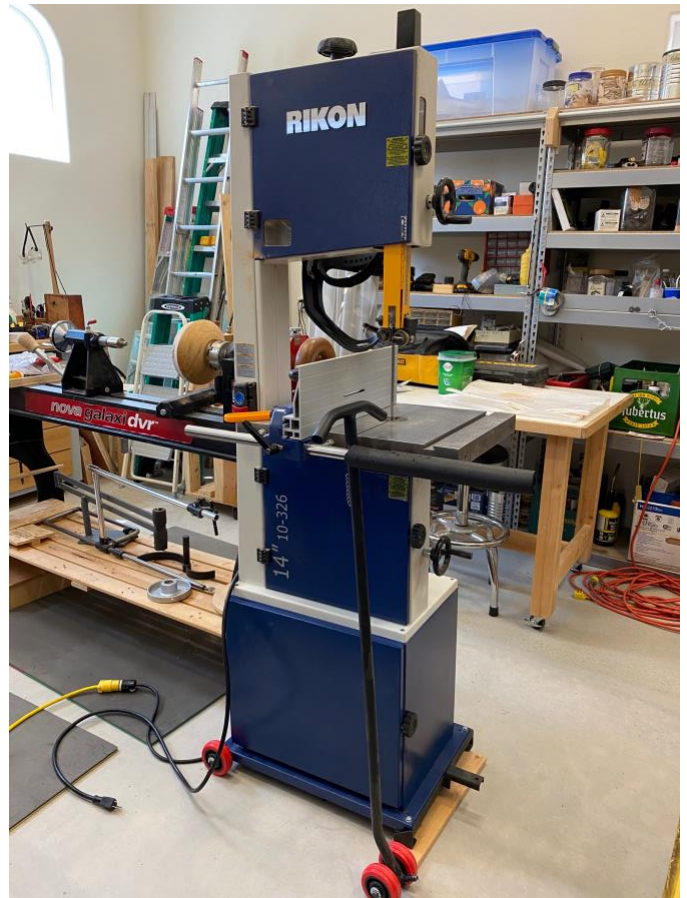

It's Your Turn...

This is Woody Stone, the current NMWT photography chairperson. Woody resides in Sandia Park and turns in his climate-controlled garage shop. Woody's shop is located in a single car width garage stall that can be shut off from the remainder of the garage. This really cuts down on the dust that we all know can migrate with ease.

At the very center of Woody's shop is a Laguna Revo 2436 lathe outfitted with many bells and whistles including a tailstock swing away, dust collection hood, integrated LED lamp and controls on both the right and left of the turner. In order to comfortably turn, mostly bowls and vessels in Woody's case, he has outfitted the lathe with several stages that fit into and around the legs as adjusting the lathes height has some limitations. In the photo below, you can see the stages that are pieced together to give Woody access all around the machine.

Woody has increased his productivity by making things at the lathe convenient for him. He upgraded to a Oneway banjo, piped in compressed air and has a vacuum chuck at the ready. Less time looking for stuff and more time turning!



It's Your Turn Cont'd



Just to the right of the lathe, wood has a large workbench that holds all the accessories including chucks, sanding supplies and tools. Woody says he's a huge fan of modular tool handles and interchangeable gouge and cutters.

After recently completing a 3-day class with Trent Bosch in his Colorado studio, Woody made some tool holders to contain Trent's proprietary hollowing tools including the HSS and carbide cutter versions. Behind his hollowing tools, Woody created a PVC and plywood rack to house handled tools for easy access. Not pictured are several chucks and faceplates on a slanted board with large pegs to slide the threads over.

Across the shop, Woody has a small midi lathe near the air compressor and dust collector. The wall with safety gear at very bottom, is easy to access and convenient so safety is not put on the back burner. Behind the lathe, Woody has another workbench where finishing and other work can take place. Finally, across the garage and in a climate-controlled room, Woody has his timber storage area. Here he has rough turned bowls slowly seasoning in paper bags. Keeping wood, especially green wood, where air flow is limited and fluctuations in temperature really keep the wood from moving drastically. What a wonderful set up, Woody!

NMWT Bylaws Update – PLEASE REVIEW

***** Proposed updates are noted in RED *****

BYLAWS New Mexico Woodturners, Inc.

Article I - Name

The name of this non-profit corporation shall be New Mexico Woodturners, Inc., located in the State of New Mexico. The official acronym shall be "NMWT" and hereinafter referred to as the Chapter.

Article II- Purpose and Objectives

1. The Chapter shall, at all times, maintain its designation by the State of New Mexico and the Internal Revenue Service as a valid 501(c)3 organization. The Chapter, shall at all times, maintain its status as a valid Chapter of the American Association of Woodturners (AAW).
2. The Corporation is organized **primarily** for educational purposes and its mission is to educate woodturners and the public, in and about the art and craft of woodturning. This mission will be accomplished by encouraging and facilitating the establishment of training programs for woodturners; by disseminating information about sources of material and equipment; by exposing the art of woodturning to the public; and by serving as a center of information about woodturning for members, galleries, and other interested groups and the general public. Further, the Chapter is organized **primarily** for educational purposes within the meaning of section 501(c) (3) of the Internal Revenue Code.
3. No part of the net earnings of the Chapter shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Chapter shall be authorized and empowered to reimburse all reasonable costs incurred by Chapter members for approved out-of-pocket costs and services rendered in response to a request by an officer or board member.
4. Notwithstanding any other provisions of these articles, the Chapter shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income tax under section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
5. This organization may from time to time engage in certain non-educational activities that are considered peripheral to its primary educational mission. These activities may include, without limitation, social gatherings to promote membership, raffles, or other fundraising activities to support the educational mission and the general operating expenses, as well as other activities that may be identified and approved by the Board of Directors.

Article III- Membership

1. **Qualifications:** Any person, firm or corporation engaged in woodturning or interested therein, may become a member.
2. **Categories of Membership:** There shall be the following categories of membership in the Chapter:
 - a. A regular member is any one person, business, or corporation who practices woodturning as a profession or avocation or is interested in woodturning.
 - b. A family/household member is all people living together in a household who practice woodturning as a profession or avocation or are interested in woodturning.
 - c. A contributory member is one who elects to pay \$100.00 or more for an annual membership.
~~There shall be 3 levels of contributory membership: Supporter Member, Sponsor Member, and Patron Member.~~
 - d. Student Membership: A person 18 years of age or less, or 21 years of age or less and a full-time student at an accredited university, college, or vocational institution. Dues of student members shall be ~~(\$10 or \$15 per year suggested rather than) one-half that of individual members.~~
 - e. Founding Member: A member who made a contribution in the calendar year 1992. The founding members are Dr. Ken Bray, Bill Zerby, Red Hollenbach, K.G. Brown, Myron Montman, and Bart Wolf.
 - f. Honorary Lifetime Member: A member or non-member who, in the Board's judgment, has made an extraordinary contribution to the NMWT Chapter and/or to the advancement of woodturning.
3. **Membership Qualifications:** A person, firm or corporation may become a member by written application on forms provided by the Chapter, accompanied by payment of one year's dues, ~~to an officer of the Chapter.~~

Article IV – Dues

1. **Annual Dues:** The Board of Directors may determine from time to time the amount of ~~initiation fee, if any, and~~ annual dues payable to the Chapter by members.
2. **Payment of Dues:** Renewal Dues shall be payable ~~no later than the last day of February during~~ the anniversary month of the member.
3. **Default and Termination of Membership:** When any member shall be in default in the payment of dues for a period of ~~one month~~ two months from period of which such dues become payable, the member's membership will thereupon be terminated. ~~The Board has the option of a grace period due to special circumstances.~~

Article V - Meetings

1. **Meetings of the Chapter:** Meetings of the chapter shall be held at times and places established and published by the Board. Regular meetings, such as educational workshops, demonstrations, and seminars, will be, in general, held monthly. ~~Meetings shall simultaneously be broadcast via electronic media to the extent possible given the Chapter's technological capability.~~
2. **Annual Meeting:** The Annual Meeting shall be held once each year at the beginning of the November general meeting in Albuquerque, New Mexico at a location designated by the Board of Directors unless a notice of a different meeting time and place, signed by the Secretary, shall be published in the newsletter, "High Desert Turning" and delivered to the members by mail or email not less than seven (7) days before the time of the meeting. ~~During the Annual Meeting, the election of officers and other necessary business will be conducted. The Annual Meeting shall be held once each year at the beginning of the 9:30 a.m. on the first Saturday of November, in Albuquerque, NM, at a location designated by the Board of Directors unless a notice of a different meeting time and place, signed by the secretary, shall be published in the Newsletter, "High Desert Turning", and delivered to the members by mail or e-mail not less than seven (7) days before the time of the meeting.~~ During the Annual Meeting the election of Officers and other necessary business shall be conducted.
3. **Special Meetings:** Special meetings may be called by the President, by a majority vote of the Board, or a majority vote of those present at any regularly scheduled meeting. Notice of a special meeting shall be published in the "High Desert Turning", at least 30 days prior to the date of the special meeting. The notice will show the time and place of the meeting and will include a proposed agenda.

- a. **Quorum:** The presence in person or by proxy of 25% of members of the Chapter entitled to vote shall be necessary to constitute a quorum for the transaction of business. All categories of paid memberships are entitled to vote if their dues are paid current. **Attendance by electronic means is a qualified way to achieve a quorum.**
- b. **Voting:** Only dues-paying members may vote. Each dues-paying member shall be entitled to only one vote. Each family/household member shall be entitled to only one vote despite the number of individuals in the family and household. If the manner of deciding any question has not been otherwise prescribed, it shall be decided by a majority vote of the members present in person or by proxy, assuming that a quorum is in attendance. **The Treasurer will determine dues payment status.**
- c. **Proxies:** Every member of the Chapter entitled to vote at any meeting thereof may vote in proxy. A proxy shall be in writing and revocable at the pleasure of the member executing it. Unless the duration of the proxy is specified, it shall be invalid after eleven months from the date of its execution. **Proxies shall be sent to the Treasurer by US Postal Service or emailed at least five (5) days prior to the vote and shall specify the person entitled to vote on behalf of the member.**
4. **Board Meetings:** There shall be the following criteria for Board meetings:
 - a. The Board will meet regularly during the year.
 - b. A majority vote shall govern unless otherwise specified.
 - c. A quorum shall be ~~one-third (1/3)~~ fifty-one percent (51%) of the Board members and shall include at least two Board Officers.
 - d. The Board shall have the option of meeting by telephone or electronic device deemed appropriate to conduct ~~special~~ **any** Board meetings. Such special Board meetings shall include at least two (2) Board Officers.
 - e. Board meetings are open to the general membership. **If conducted electronically, any member may receive a meeting link if the member sends a request at least five (5) days in advance of the Board meeting.**

Article VI - Officers

1. **Officers:** The officers of this Chapter, in order of hierarchy, shall be a President, a Vice President, a Secretary, and a Treasurer. These officers **comprise the Executive Committee and** shall serve on and be included in the Board. The officers of the Chapter will also serve as the Directors of the Chapter. All officers shall be members in good standing of both the Chapter and the AAW.
- a. **President:** The President shall be the chief executive officer of the Chapter. His duties and responsibilities shall include:
 1. Supervise and control all business and affairs of the Chapter.
 2. Conduct Chapter and Board meetings.
3. **Prepare, with the Treasurer, a fiscal budget for the following year. The budget shall be submitted to the Chapter for approval by the general membership at the first meeting of the new calendar year.**
4. Is an *ex-officio* member of all committees except the Nominating Committee.
- b. **Vice President:** In the absence of the President or in the event of the death, resignation, inability, or refusal to act, the Vice President shall perform the duties of the President; and when so acting, shall have all the powers of the President. The Vice President shall organize the programs for the general meetings and perform such other duties as from time to time may be assigned by the President **and agreed to by the Board.**
- c. **Secretary:** The Secretary shall keep the minutes of topics addressed during the Chapter's Board meetings and distribute the minutes to all Board members **and will post the Minutes and any other pertinent documents to the Chapter's website. The Secretary shall confirm that the Minutes of any meeting are approved by the Board at their next meeting.** The Secretary will assure that all notices are duly given in accordance with the provisions of these Bylaws or as otherwise required. In general, the Secretary shall perform all duties incidental to the office of Secretary and such other duties as from time to time may be assigned by the President.
- d. **Treasurer:** The Treasurer shall keep an account of all monies received and expended for the use of the Chapter and shall make disbursements for valid obligations of the Corporation. The Treasurer shall deposit all sums received in a bank, or banks, or trust company approved by the Board, and make a report at the annual meeting or when called upon by the president. Funds may be drawn only upon the signature of the Treasurer or President if the Treasurer is unavailable. The funds and records in the possession of the Treasurer shall at

all times be under the supervision of the Board and subject to its inspection and control. At the expiration of the Treasurer's term of office, the Treasurer shall deliver over to the successor all books, monies, and other properties, or in the absence of a Treasurer-Elect, to the President. In the case of absence or disability of the Treasurer, the President may appoint a treasurer *pro tem*.

- i. The Treasurer shall keep a General Roster of all Chapter members with contact information.
- ii. The Treasurer will present a summary of the Chapters finances at each Board meeting of the year, or at any time and period requested by the President. The summary report will include sources and uses of cash during the year along with starting and ending cash balances.
- iii. The Treasurer will provide a brief oral report of the Chapter's finances at the Annual Meeting and with the President will prepare and present the annual budget to the general membership for approval at the first regular meeting of the new year.
- iv. At the discretion of the President or the Treasurer, the Board may appoint an Audit Committee of one or more members to audit the Chapter's financials.

2. Election of Officers:

a. Nominating Committee. The Board shall appoint, in September of each year, a nominating committee consisting of members in good standing. The nominating committee will offer its nominations for officers and directors to the Board in October. At the November meeting, additional nominations of members who have agreed to serve if elected, may be made from the floor.

- i. The nominating committee shall consist of not less than two members-at-large and will be chaired by one of the Officers, excluding the President.
- ii. The nominees will be announced and published in the Newsletter preceding the Annual Meeting. Nominations may be taken from the floor during the meeting.

b. Voting:

- i. An election of Officers shall be held at the Annual Meeting in November.
- ii. Voting shall be by paper ballot or by a voice vote of those members present by acclamation.
- iii. Absentee votes may be mailed to the Secretary to arrive before the meeting.
- iv. A majority vote of the members present (including absentee votes) shall constitute an election.
- v. Members attending by electronic means shall have their vote counted by a Board Officer.

3. **Terms of Office:** Each officer shall hold office for a period of one year, subject to removal. The term of office shall begin on January 1 and continue through December 31.

Article VII - The Board

Definition: The four Officers and Committee Chairs shall comprise the Board of Directors.

1. **Committee Chairs:** The Officers may select additional Board Members or other Committee Chairs as needed for the organization to function efficiently each year. ~~The Officers may designate whether the functional volunteers will be voting Board Members, or non-voting Committee Chairs. Board Members are expected to attend regular Board meetings and have the right to vote, while Committee Chairs are not required to attend and do not vote on Board motions. Committee Chairs may attend, as may any member of the organization.~~ All Board members may vote. If the meetings are conducted live or electronically, all Board members present may vote and a majority of those present will carry the motion. Board members and Committee Chairs are expected to attend Board meeting.

2. The Committees are designated as the following:

- a. Apparel and Other Sales
- b. Auxiliary
- c. Education
- d. Equipment/Workshops
- e. Greenwood
- f. Librarian
- g. Member-at-Large
- h. Membership

- i. Newsletter
 - j. Photography
 - k. Raffle
 - l. Special Projects
 - m. State Fair
 - n. Video
 - o. Web
 - p. Women in Turning
3. After the election of the Board each year, the Board shall nominate and approve by majority vote of the Board the persons to serve as Committee Chairs.
 - a. At the discretion of the Board, Committee Chairs may be left vacant.
 - b. The Board may **alter the number of Committees** by majority vote of the Board.
 - c. Persons serving as Committee Chairs may be removed by a majority vote of the Board.
 4. **Duties of the Board:** The Board may:
 - a. Hold meetings at such times and places as it chooses **with adequate notice, including online meetings.**
 - b. Print and circulate documents and publish the “High Desert Turning” newsletter.
 - c. Communicate with other organizations interested in woodturning
 - d. Employ agents.
 - e. Devise and execute such other measures as it may deem proper to promote the objectives of the Chapter and to best protect the interest and welfare of the members.
 - f. The Board shall transact the business of the Chapter. The Board shall authorize all expenditures and shall not create any indebtedness in excess of the Chapter’s resources. **Any expenditure in excess of \$1000 shall be submitted to the general membership for approval.** Expenditures identified in the annual budget and approved by the general membership may be authorized by the Board without further submission to the membership.
 - g. No compensation shall be paid to Board members for their services. However, members shall be entitled to reimbursement for expenses in carrying out the duties of office when pre-approved by the Board and recorded in the Minutes of the Board.
 - h. **Any Chapter member, including the Board members, may be paid the standard presentation rate for major presentation at any meeting.**
 5. **Board Criteria:**
 - a. No Officer shall hold more than one office.
 - b. The Board may appoint as many Committee Chairs as deemed necessary.
 - c. All Committee Chairs shall be members of NMWT.
 6. **Removal:** Any member of the Board may be removed from office when it is deemed that the best interests of the Chapter would be served by such removal. Removal will be accomplished by a two-thirds majority vote of the Board using secret ballots. Ballots will be counted by three non-Board member volunteers. Verbal and written notice shall have been given to the individual **at least five (5) days** prior to the Board’s deliberations. The individual shall have the rights of defense and appeal to the general membership.
 7. **Vacancies:** A vacancy in any office shall be filled for the remainder of the unexpired term by a majority vote of the Board. If the positions of President and Vice President are simultaneously vacant, *President pro tem* shall be appointed by the remaining members of the Board. The *President pro tem* shall appoint a *Vice President pro tem*, subject to the consent of the Board. The term of the *President pro tem* shall be until the end of the year in which they take the position.

Article VIII - Indemnification

1. **Board Members:** Each person who has been, now is or shall hereafter be a member of the Board, an officer or committee member of the Chapter shall be indemnified by the Chapter to the extent of its treasury funds and as permitted by law against all expenses reasonably incurred by the Board Member in connection with any action, suit, proceedings or the settlement or compromise thereof, or payment of any judgment or fine resulting therefrom in which the Board Member may become involved by reason of any action taken or omitted by the Board Member provided that such action was taken or omitted in good faith for the Chapter.

2. The Chapter:

- a. The Chapter shall not be liable for any bodily injuries or damages resulting from the operations and activities of the Chapter.
- b. The Chapter shall be responsible for expenses incurred at its direction in connection with its operations, functions, and activities.

ARTICLE IX – Dissolution

By two-thirds vote of all the members of the Chapter, the Chapter may be dissolved. Upon the dissolution of the Chapter, the Board shall, after paying or making provisions for the payment of all liabilities of the Chapter, dispose of all assets of the Chapter exclusively for the purposes of the Chapter in such manner or to such organization or organizations organized and operated exclusively for educational purposes as shall at the time qualify as an exempt organization or organizations under section 501(c) (3) of the Internal Revenue Code (or the corresponding provision of any future United States Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by an order of the proper court, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. In no event shall the assets of the Chapter be distributed to or inured to the benefit of any individual member.

Article X - Amendment of Bylaws

These Bylaws may be amended repealed or altered in all or in part at any scheduled meeting of this Chapter by a two-thirds vote of the members present. A notice of such proposed amendment shall be announced in the Newsletter and/or transmitted to all members who have a valid registered email or street address at least ten days prior to the date of the meeting at which the amendment is to be considered.

Article XI - Parliamentary Authority

The rules contained in the current edition of *Roberts Rules of Order* will be used as guidance to govern the Chapter to the extent they are applicable and not inconsistent with these Bylaws and any special rules of the Chapter.

Article XII – Notifications

Official Notifications to Members shall be made by email or US Mail to the addresses current in the General Roster of the Chapter. It is the responsibility of individual Members to maintain an accurate address with the Treasure. Paper and/or electronic records shall be deemed sufficient for notifications.

ARTICLE XIII - Relationship to American Association of Woodturners

The New Mexico Woodturners: The NMWT's were organized as a Local Chapter of the American Association of Woodturners (AAW) on August 25, 1992. The AAW is a 501(c) (3) educational nonprofit corporation. All officers of the Chapter agree to be members in good standing of the AAW. The Chapter will encourage all members to become members of AAW. The AAW specifically disassociates itself from any debts, obligations, or encumbrances of the Chapter. The AAW does not shoulder any legal liability for accidents that occur during events of any kind sponsored by the Chapter. The Corporate Board Directors of the American Association of Woodturners is not responsible for any debt nor will it share in any income of the Local Chapter.

American Association of Woodturners: The AAW furnishes liability insurance for the Chapter. Only AAW members will be insured under this policy for claims that may be brought against them for bodily injuries or damages that they may have caused to another person while performing an NMWT sanctioned activity.

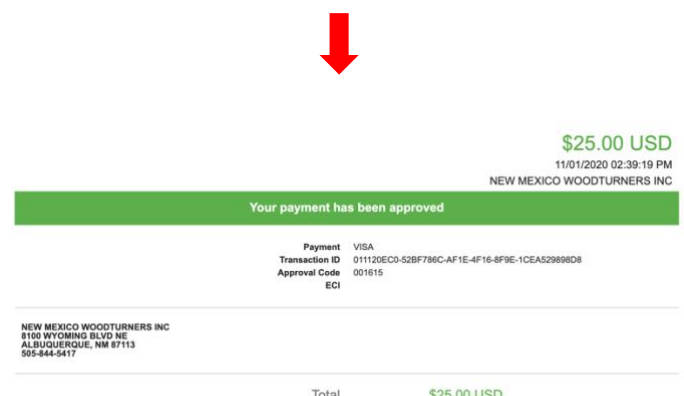
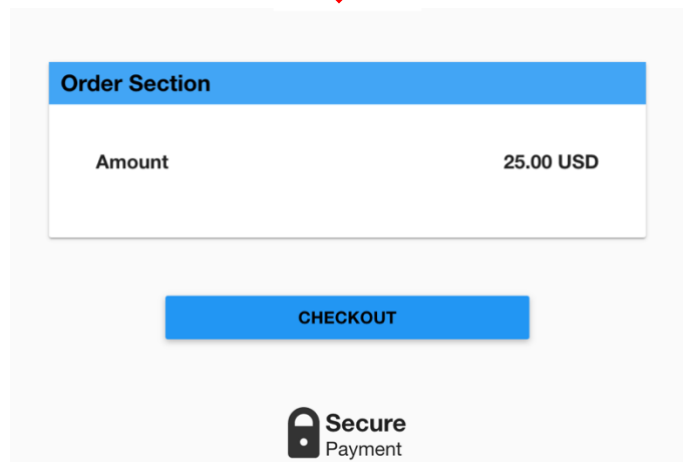
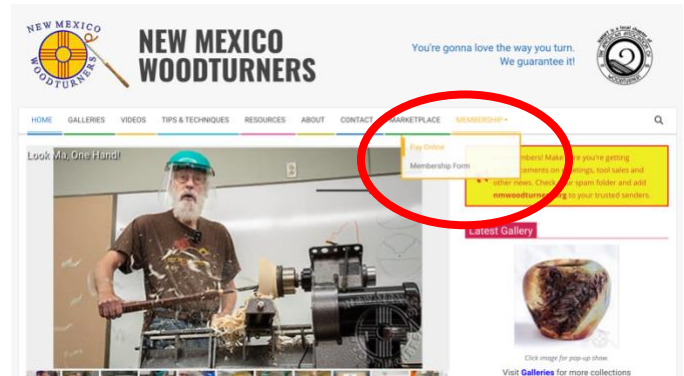
Web-Based Credit Card Dues Payment Now Available

Most of our NMWT memberships are currently set up on a calendar year basis with expirations at the end of December. So now is the time to start renewing memberships for 2021 and beyond for those who need to (your current membership expiration date should be listed on your membership card).

We are very pleased to announce that you can now pay your membership dues with a credit card on the NMWT website at <https://www.nmwoodturners.org/>. To access online dues payment, simply go to the new “Membership” tab near the top of the homepage and select “Pay Online” from the drop-down menu. This will take you to a secure website managed by Converge, our credit card service provider.
